3. Treasurer Report - Herman Spiess

- Financial Summary as of October 29, 2019 submitted: Bank Balance 10/31/18 \$13,473.72, dues collected -\$17,406.00, expenses \$15,238.06, Current Bank Balance \$12,248.06, outstanding dues cumulative total \$3,500.00, Budgeted expenses for 2018 \$15,350.00, Average cost per household \$100.00.
- We have been successful in the collection of outstanding dues to a manageable level. The bulk of
 those dues outstanding from 2019 will more than likely be paid after this year's billing is sent out.
 Late charges are added to outstanding dues, but usually not the first year. Those that need more
 persuasion are turned over to an attorney. All costs (attorney, court, etc.) are billed to the
 individual homeowner.
- All realtors are aware of homeowners' association and contact H. Spiess for the resident's status prior to sale. New homeowner's names are being supplied.
- We currently have two good companies for grass cutting and landscaping.
- Rainbow will be providing snowplowing services again this year same price for 2020 as last year. Salting will be done per request. Snowplowing has already been paid for the upcoming winter.
- Northern Lights will be putting up the Christmas lights at the entrance. At the end of the season, they will be storing the lights for us.
- Dues will remain the same as last year.
